Opening the Meeting:

Following dinner, fellowship, passing of the peace, and prayer, a quorum was declared, and the meeting was called to order by the Moderator, Pastor Phil Hargrove.

Ministry and Committee Reports:

- Adult Ministry Pam Douthit Ministry groups are very active and looking forward to fall activities.
- Budget & Finances Rita Peterson In September, Bonhomme recognized \$195,923 of operating revenue and \$232,515 of expenses, generating a deficit of (\$36,592) for the month. This reduces our yea-to-date surplus to \$9,091.
- Building and Grounds Keith Whittemore A review of recent roof repairs was
 discussed, and potential future repairs were identified. At some point, in the near future,
 funding for major replacements will need to be considered. Currently the ministry has
 been working on the 2020 budget and reviewing potential issues for longer term
 budgeting.
- Children's Ministry Jeanne Luther Kid's Church is off to a good start, and the kids are really enjoying it. Sunday School is going well more kids with more consistency so far. We have some awesome HS students helping and Jeanne wants to get them to start teaching the lesson some Sundays.
- Community Care Jenni Stecher Activities are continuing.
- Guest Ministry Deb Hawley Guest Ministry has moved from John Green to Robby Cella. Our first "guest dinner" will be at the Hargrove home on 11/14. A small group of new young families have been invited.
- Human Resources Commission Cliff VanIttersum HRC is working on a number of policy initiatives which will be presented at the Session meeting.

- Nominations and Lay Leadership Cliff VanIttersum Matt Brandenburg (Mission) and Jennifer Kroll (Community Care) were approved by congregational vote on 09/29/19 to serve as deacons. They were ordained and installed on 10/20/2019. NLL will hold a training class for them and any other officers who would like to attend during the deacon cabinet meeting on 11/05/19 6:30pm Room 3205.
- Missions Keith Whittemore Mission Ministry will provide Communications Director materials each month for a spotlight in the Pioneer Press. Each program would contribute once per year. Funds originally designated for Ethiopia but not dispersed, will be donated to Samaritan's Purse for the South Sudan Project which is a similar purpose as originally intended.
- Student Ministry Fred Breitenwischer September SM Leadership meeting key topics discussed: Breakfast at Bonhomme preparation, Bingo/Trivia communication, Lou Connect sign ups and confirmation report out by Drew.
- Worship Jenny Brown and Chad Schrieber Coordination is proceeding with both services.
